

AESA Cortaillod Cookies policy

Last updated: March 5th, 2021

This cookies policy is part of AESA Cortaillod data protection system. It describes the usage of Cookies by AESA Cortaillod on its website <u>www.aesa-cortaillod.com</u>.

"Cookies" are small pieces of data that a website asks your browser to store on your computer or mobile device. Cookies contain an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server. Cookies do not typically contain any information that personally identifies a user, but personal information that We store about You may be linked to the information stored in and obtained from Cookies. The identifier itself may be considered as personal information regarding You.

Please read this Notice carefully to understand how We use Cookies on our Website. Please also note that this policy is part of the AESA Cortaillod Privacy Policy, which explains more broadly how We process your Personal Data.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Cookies Policy:

- **AESA** (referred to as either "AESA", "We", "Us" or "Our" in this Agreement) refers to AESA Cortaillod, 2022 Bevaix, Switzerland and its subsidiary companies.
- **Cookies** are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Device means any device that can access the Website such as a computer, a cellphone or a digital tablet.
- Personal Data is any information that relates to an identified or identifiable individual.
- **Usage Data** refers to data collected automatically, either generated by the use of the Website or from the Website infrastructure itself (for example, the duration of a page visit).
- Website refers to AESA Cortaillod website, accessible from www.aesa-cortaillod.com
- You (referred to as either "You" or "Your" in this Agreement) means the individual accessing or using the Website, or AESA, or other legal entity on behalf of which such individual is accessing or using the Website, as applicable.

Tracking Technologies and Cookies

We use Cookies and similar tracking technologies to track the activity on Our Website and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze Our Website.

Cookies can be "Persistent" or "Session" Cookies. Persistent Cookies remain on Your personal computer or mobile device when You go offline, while Session Cookies are deleted as soon as You close Your web browser.

We use both Session and Persistent Cookies for the purposes set out below:

Necessary / Essential Cookies

Purpose: These Cookies are essential to provide You with services available through the Website and to enable You to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts. Without these Cookies, the services that You have asked for cannot be provided, and We only use these Cookies to provide You with those services.

Cookies Policy / Notice Acceptance Cookies

Purpose: These Cookies identify if users have accepted the use of cookies on the Website.

Functionality Cookies

Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.

Statistics Cookies

Type: Statistics

Default expiration time: 2 years from set/update

This cookie is set by Google Analytics and is used to distinguish users and sessions. The cookie is created when the JavaScript library executes and there are no existing __utma cookies. The cookie is updated every time data is sent to the Google Analytics.

_utmc

Type: Statistics

Default expiration time: end of browser session

The cookie is set by Google Analytics and is deleted when user closes the browser. The cookie is not used by ga.js. The cookie is used to enable interoperability with urchin is which is an older version of Google Analytics and used in conjunction with the __utmb cookie to determine new sessions/visits.

_utmz

Type: Statistics

Default expiration time: 6 months from set/update This cookie is set by Google Analytics and is used to store the traffic source or campaign through which the visitor reached our site.

_utmt

Type: Statistics Default expiration time: 10 minutes The cookie is set by Google Analytics and is used to throttle request rate.

_utmb

Type: Statistics

Default expiration time: 30 minutes from set/update

The cookie is set by Google Analytics. The cookie is used to determine new sessions/visits. The cookie is created when the JavaScript library executes and there are no existing utma cookies. The cookie is updated every time data is sent to Google Analytics.

Google Analytics in particular

The Website uses Google Analytics, an Internet site analysis service supplied by Google Inc. ("Google"). Google Analytics uses Cookies which are text files placed on your computer to help to analyze how the Website is used by its users. The Personal Data generated by the Cookies concerning your use of the Website will be forwarded to, and stored by, on servers located in Ireland. We have set the parameters of Google Analytics in order to anonymize all IP addresses that are collected in this context. Hence, no personal information that may allow identifying you is stored through this
